Eligibility: All Company's, Corporations & Qualified Consultants based in North-America are eligible for Membership in NAUMD.

- ASSOCIATE:** Companies that supply ingredient products (piece goods, mills, trim, etc.) and services to the uniform industry, on the basis of their annual sales and the following schedule.
- DEALER/DISTRIBUTOR:** Firms that are principally engaged in direct sales to the end user, and purchase for resale the majority of their uniform items, on the basis of annual sales/following schedule.
- MANUFACTURER:** Companies that are engaged in the manufacturing of uniform items for resale to distributors and/or end users, based on their annual sales to the Uniform Industry.
- UNIFORM /IMAGE FABRIC/ COLOR/ MANUFACTURING/BUSINESS CONSULTANT: Individual Person Membership Only (only the person who is the member enjoys benefits)** Must be engaged in Consultation to manufacturing of uniform items, to Uniform dealers/distributors and/or end-users, and be full time business consultants to the Uniform Industry based in North-America, to be eligible for Membership in NAUMD. They **may not** be employees of Uniform Company's or Organizations and **may not** be Sales Representatives with Manufacturers, Dealers or other product/service firms. . Manufacturers Representatives are **NOT** eligible for this category of membership.
